

# Treadwell LLC iPad Giveaway Terms and Conditions

## 1. Introduction

- Welcome to the Treadwell LLC iPad Giveaway! These terms and conditions govern your participation in the giveaway. By entering, you agree to these terms.

## 2. Eligibility

- The giveaway is open to legal residents of the 50 United States, the District of Columbia, and Canada who are at least 18 years old at the time of entry, except where prohibited by law.
- Employees of Treadwell LLC, its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members are not eligible to participate.
- To be eligible, participants must submit a "successful referral" for a new customer, per the "How to Enter" definition below.

## 3. Entry Period

- Each successful referral equals one entry into the giveaway. Multiple entries are allowed according to the rules above, with a maximum of five (5) entries per person.
